**1966 DISTRICT & COUNTY COUNCIL MATTERS**

Councillor Robin Munday on the proposed partnership with East Devon. East Devon is comparable in terms of size, the proposals would mean 1 chief executive over both authorities with a gradual change of directors. The plans would mean a way of saving without cutting costs. P Sort it Plus (cardboard and plastic) may happen because the district has reduced the cost if all of the Somerset District Councils agree to purchase the scheme. The start date would probably be midway through the next financial year.

The budget has been balanced. Band D Council tax is £150 with a 2% increase.

Councillor Robin Munday had looked at the land by the band hut and it is Council property. There may be enough space for 2 or 3 allotments but the land has to be strimmed first to assess it properly.

Councillor Kim Turner reported that the cabinet had met to discuss budgets, it has achieved a 0% increase in Council Tax as promised but this will inevitably lead to cuts in services. There will not be a community budget, they have reduced Highways budget by £5million.

Planning Issue 10/00335/CPO is applied to the County council and not the District. Councillor robin Munday commented that there would be 5 delivery vehicles per day but as it is already used by contractors this may not be an issue. It would deal with 8000 tonnes pa. *Action: The Parish Council will hols a separate planning meeting.*

Councillor Kim Turner reported on a meeting she had attended regarding Somerset schools. She thought that the school needed to pursue Hard Federation. Councillor Mary Haggard commented that the school had approached a number of different school but had been unsuccessful so far.

Councillor Robin Munday reported that the freehold would stay with the estate, the amendment is to release the land to build holiday lodges and run them. Councillor John Gaper commented that the application requested a 999yr lease. The Parish Council recommend approval if the lease is 99yrs.

a) Councillor Andrew Partridge had nothing new to report. Councillor Roger Beer requested that the Parish Council orders the repairs for the multiplay. The Parish Council stated that it was financially viable. Motion Carried. *Action: Clerk to order.*

b) The Clerk reported to the District and County Councillors that they could not progress further without professional help but they could not get through to the Play team despite repeated efforts. Councillor Kim Turner offered to follow this up and help arrange a new meeting. She also suggested contacting Simon Preston in the Rural Youth Scheme for advice.

Councillor Roger Beer asked Councillor Kim Turner if she would support the project financially. *Action: Clerk to apply for funding for the project and grit bins for the village.*
